The Donehoo Elementary School will:

 - Parents will be encouraged to join PTSO which meets monthly to discuss the "State of Donehoo" and desired activities for students.
 - Additionally, teachers will encourage parents to sign up to volunteer through homeroom rosters.
6. **Ensure regular two-way, meaningful communication between family members and school staff, and, to the extent practicable, in a language that family members can understand.**
 - *C.A. Donehoo will use: Schoolcast, Monthly Calendars, Remind, DOJO, School Notes, Facebook, Twitter, and the school website to communicate with families.*
 - Information will be shared in English and Spanish
